Your use of any aspect of InnovateDefense.net will constitute your consent to comply with this Agreement. If you cannot agree with these rules, please do not use InnovateDefense.net.

Please note that certain parts of InnovateDefense.net may have separate terms of use and privacy policies ("Special Rules"), which will govern your use of those parts of InnovateDefense.net. In the event that there is a conflict between the Special Rules and this Agreement or the InnovateDefense.net Privacy Policy, the Special Rules shall govern.

The Agreement may be modified from time to time; the date of the most recent revisions will appear on this page. Continued access of InnovateDefense.net by you will constitute your acceptance of any changes or revisions to the Agreement.

Introduction

The National Security Innovation Network ("NSIN") including the website and pages located at InnovateDefense.net ("InnovateDefense.net"), are a United States Department of Defense initiative from the Defense Innovation Unit ("DIU"). InnovateDefense.net is designed to enable innovation by supporting conversations and collaborations among our registered users ("Members") to support dual-use innovation opportunities that benefit the development of technologies that have applications in the defense and security sectors.

Participation

Eligibility – You promise that you are eligible to enter into this Agreement and you are at least our "Minimum Age." To use the Services, you agree that: (1) you must be the "Minimum Age" (defined below) or older; (2) you will only have one InnovateDefense.net account; and (3) you are not already restricted from using the Services. "Minimum Age" means (a) 18 years old for the People's Republic of China, (b) 16 years old for the Netherlands, (c) 14 years old for the United States, Canada, Germany, Spain, Australia and South Korea, and (d) 13 years old for all other countries. However, if law requires that you must be older in order for InnovateDefense.net to lawfully provide the Services to you (including the collection, storage and use of your information) then the Minimum Age is such older age. The Services are not for use by anyone under the age of 13.

Membership – As a Member, you promise that you will keep your password a secret. You will not share an account with anyone else and will follow our rules and the law. As between you and others, your account belongs to you. You agree to: (1) try to choose a strong and secure password; (2) keep your password secure and confidential; (3) not transfer any part of your account (e.g., connections, groups) and (4) follow the law and the terms of this Agreement. Notices and Service Messages – You consent to us using our InnovateDefense.net and email to provide you with important notices. Also, you agree certain additional information can be shared with us. If the contact information you provide isn't up to date, you may miss out on these notices. You agree that we may provide notices to you in the following ways: (1) a banner notice on the Services, (2) an email sent to an address you provided, or (3) through other means including mobile number, telephone, or mail. You agree to keep your contact information up to date.

Utilization

- Scrape or copy profiles and information of others through any means (including crawlers, browser plugins and add-ons, and any other technology or manual work);
- Act in an unlawful, libelous, abusive, obscene, discriminatory or otherwise objectionable manner;
- Violate intellectual property rights of others, including patents, trademarks, trade secrets, copyrights or other proprietary rights;
- Violate the intellectual property or other rights of InnovateDefense.net;
